INVITATION FOR BIDS

1. This Invitation for tender follows the General Procurement Notice for this project which was advertised on **23rd July, 2018**.
2. The Government of Tanzania has set aside funds for the operations of the National Examinations Council of Tanzania (NECTA) during the financial year **2018/2019**. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the supply of goods and services.
3. The National Examinations Council of Tanzania now invites sealed bids from eligible Suppliers and Service Providers to participate for the bids mentioned below:

A complete set of Bidding Document(s) in English and additional sets may be purchased by interested Bidders on the submission of a written application to the address given in paragraph **5 above** and upon payment of a non-refundable fee **indicated on para 3 above**. Payment should be made to the National Examinations Council of Tanzania through **AccountNo: 20101100238 NMB Bank House** and **Account No: 01J1013540000 CRDB Kijitonyama Branch** payable to National Examinations Council of Tanzania.

All bids submitted by local bidders must be accompanied by **Bid Securing Declaration** in the format provided in the tender documents **while** bids submitted by foreigner bidders **must** be accompanied by a **bid security of two percent(2%)** of the total bid price in an acceptable form or any freely convertible currency in case of foreign Tenderers.
1. All bids in one original plus two copies properly filled in, and enclosed in plain sealed envelopes clearly marked '**tender number**' must be delivered to the address given in paragraph **5 above** on or before the time and date indicated on the table given in paragraph **3 above**.
2. All bids will be opened promptly thereafter in public and in presence of bidder's representatives who choose to attend in the opening ceremony to be held at **PMU Hall – Stores Building, National Examinations Council of Tanzania, Plot no: 53319/28349, New Bagamoyo Road –Adjacent to TBC1-Dar es Salaam**.
3. Late Bids, Portion of Bids, Electronic Bids, Bids not received, Bids not opened and not read out in public at the bid opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
